A. Medical Claims Audit - BMI - Informational -

BMI chosen to do audit. Results have come in. 19,241 claims were electronically audited with \$9.2M in payments for the period of 7-1-18/6-30-19. 100 claims picked to manually audit for further review. These represented \$1.4M in claims.

BMI very complimentary of the job that HealthComp is doing.

No flags on Financial impact or Fraud/Waste areas.

Timely reporting of terminations still a problem. RealCare will go out with an email blast reminding everyone of the importance of timely terminations and send along an updated Benefit Administration Manual.

DME Prior Authorizations are not being done. Will Anthem do? If not, will HealthComp do? Do we want to put a dollar amount on DME before PA's are required? RealCare will investigate with HealthComp.

HealthComp researching claim problems and we will report back to Committee with results.

Will do another medical claims audit in 2 years.
